Legislative Update for Local 943 February 25th, 2025

Each year, the IFT introduces an advocates for legislation to ensure high-quality public services and public education for all Illinois residents and students. The IFT also opposes legislation that does NOT support public services and education. The IFT and positions are based on resolutions passed by elected delegates at the IFT convention.

FY26 Budget

Governor JB Pritzker outlined his Fiscal Year 2026 budget proposal on February 19. Over the next eight weeks the House and Senate Appropriations Committees will take testimony on proposed budget items and begin the process of crafting the FY26 state budget.

Overview of Governor Pritzker's Proposal:

The FY26 proposed spending plan is estimated to total \$55.234B, which is a 2.5% increase in state spending compared to the FY25 revised estimated spending plan.

The governor's proposed FY26 budget allocates \$78 million as an additional contribution for adjusting the Social Security Wage Base for Tier 2 members.

The proposed budget includes continued, increased investments in early childhood, the K-12 evidence-based funding model, and colleges and universities. It also includes the full payment to the state's pension systems.

The governor's proposed budget is the starting point for budget negotiations with a final budget to be passed in late May. IFT will be advocating for our budget priorities throughout the spring in the House and Senate Appropriations committees. Below is a more detailed outline of the governor's proposal.

Pensions

- Makes the full payment to the state's pension systems including TRS, SURS, and SERS.
 - o The total pension payment is \$10.6 billion or 19.7% of the state budget.

Education

- Early Childhood
 - o Smart Start Illinois continues investment in the Smart Start Illinois initiative for a third year to eliminate preschool desserts, stabilize the childcare workforce, expand the Early Intervention Program and Home Visiting programs, plus funding to begin the overhaul of the childcare payment management system.
 - o Operational funding for the Illinois Department of Early Childhood \$21.7 million.
 - o Maintain investment in Illinois State Board of Education (ISBE) Early Childhood Block Grant Funding \$748 million.

- K-12
 - o Evidence Based Funding \$350 million increase.
 - Brings EBF program to \$8.9 billion.
 - o School Categorical Grants \$19.9 million increase (\$1.2 billion)
 - Fully funds the Special Education-Orphanage Tuition and Regular Orphanage budget lines.
 - o Teacher Vacancy Grant Pilot Program \$45 million for Year 3 of the 3-year pilot.
 - o State Literacy Plan implementation \$3 million.
 - o Career Technical Education Programs \$1.3 million increase.
 - o Computer Science Equity Grant Program \$3 million.
 - o Dolly Parton Imagination Library \$3.3 million to continue expansion of Dolly Parton's Imagination Library.
 - Today, more than 61,000 children under the age of five have been signed up to receive free books in the mail every month.
 - o Special Education Transportation \$30 million to account for increased claims by districts.
 - o National Board Certified Teachers (NBCT) level funded at FY25 level of \$4.5 million.

Health Insurance and Retiree Health Insurance

- o Teachers' Retirement Insurance Program fully funded.
- o College Insurance Program (CIP) fully funded.
- o State employee group health insurance fully funded.

School Board Elections

The next consolidated school board election in Illinois is April 1, 2025.

Key Dates:

- Tuesday, March 4, 2025
 Last day to register to vote or make an address change (excluding grace period Or
 - Last day to register to vote or make an address change (excluding grace period Online registration through State Board of Elections website will continue through March 16th)
 - Wednesday, March 5, 2025

Last day for deputy registrars to return used and unused voter registrations to the Election Office First day of grace period registration or change of address in the office of the election authority First day of grace period voting at the election authority's office

- Sunday, March 16, 2025
 Last day for voters to register to vote online through State Board of Elections website
- Tuesday, March 18, 2025
 First day a voter admitted to hospital, nursing home or rehab center not more than 14 days before an election may apply for a vote by mail ballot by personal delivery
- Thursday, March 27, 2025
 Last day to apply by mail for a vote by mail ballot
- Monday, March 31, 2025
 Last day for early voting at the office of the election authority
- Tuesday, April 1, 2025 CONSOLIDATED ELECTION DAY
 Last day of grace period registration, change of address and grace period voting
